

#### MISINFORMATION KILLS

The headlines scream that "two women died in Georgia due to antiabortion laws".

I do not dispute the facts of the story – only the headline. It should say "Two women died in Georgia because of chemical-induced abortions, and because of mis-information, started by pro-abortion zealots and spread by a complicit mass media.

- 1: They were told that the chemical abortion medication was "perfectly safe." Fact: We do not know how many women have had serious complications from this regimen, due to inadequate reporting, but we do know these two women took the abortion pills, and suffered incomplete abortions a life-threatening condition in which parts of the dead fetus remain in the uterus.
- 2: One woman, purportedly, did not seek medical care because she feared prosecution. Fact: Not one state law provides for prosecution of those seeking abortions only those who perform them.
- 3: Doctors delayed treatment of the other woman because they feared prosecution. Fact: Every state law restricting abortion provides an exception to preserve the life of the mother. The needed D&C was permitted under Georgia Law. Therefore, failure to provide that care was plainly mal-practice.

Two women died tragically and needlessly because of unwarranted fear deliberately fostered to discredit any laws restricting abortion. Three babies died too, (one pair of twins), also tragically and needlessly, and all, ultimately, as a direct result of drug-induced abortions.

But how, then, shall we vote? Here is my best thought on this morally challenging question.


